- 1.6 During the examination, applicants shall be required to select the best possible answer from the options provided.
- 1.7 The Examination Department shall be responsible for the administration and initial grading of examinations. Final grading, however, shall remain the responsibility of the Certification Department.
- 1.8 All examination questions shall be approved by the Certification Department. Questions shall be selected in a random and unpredictable manner from the RSA question bank valid at the date of the examination.
- 1.9 Written examinations, whether conducted electronically (e-assessment) or in conventional paper-based format, shall be invigilated either by an examiner or by one or more trained invigilators operating under the responsibility of an examiner.

 - c. API 574 Inspection Practices for Piping System Components
 - d. API 575 Inspection of Atmospheric and Low-Pressure Storage
- 2.1.2 The examination shall be completed within 90 minutes.

2.2 Plant Inspector

2.2.1 Requirements

- 2.2.1.1 The examinations shall consist of closed-book and opened-book
- 2.2.1.2 Pressure Vessel Inspector applicant shall be required to complete Part A and Part B examinations as specified in Table 1.
- 2.2.1.3 Process Piping Inspector applicant shall be required to complete Part A and Part C examinations as specified in Table 1.

- 2.2.2.1 The closed-book examination shall assess the applicant on knowledge and tasks requiring everyday working familiarity with the applicable reference documents listed in Table Plant Inspectors Competency Requirements.
- 2.2.2.2 The applicant shall be given a total of ninety (90) multiple-choice questions, as specified in Table 1.
- 2.2.2.3 The examination shall be completed within one hundred and fifty (150) minutes.

2.3 Specialist Plant Inspector

- 2.3.1 The Specialist Plant Inspector applicant shall be given an eighty (80) multiple-choice, closed-book examination covering the following subjects, whichever is applicable:
 - a. API 571 Damage Mechanisms Affecting Fixed Equipment in the Refining Industry.
 - b. API 579-1 Fitness-For-Service
 - c. API 580 Risk-Based Inspection.
- 2.3.2 The examination shall be completed within 180 minutes.

3.0 RE-EXAMINATION

3.1 General

3.1.1 Applicants failing for reasons of unethical behaviour shall wait at least twelve (12) months before reapplying.

- 3.1.2 Applicants who fail to obtain the pass grade for any examination part may be re-examined up to three (3) times in the failed part(s), provided that the re-examination takes place not sooner than thirty (30) days (unless further training acceptable to RSA is satisfactorily completed), and not later than three (3) years after the original examination.
- 3.1.3 Applicants may take the first retest of the failed part(s) without additional training. Only one retest without documented evidence of additional training is permitted.
- 3.1.4 Applicants failing all permitted re-examinations shall apply for and take the full examination in accordance with the procedure established for new personnel.

3.2 Assistant Plant Inspector

Assistant Plant Inspector applicant taking 2nd or 3rd retest shall require documented evidence of additional training in accordance with Section Training Requirements- Assistant Plant Inspector.

3.3 Plant Inspector

Plant Inspector applicants taking a second or third retest shall provide documented evidence of additional training in accordance with the following:

- a. Full 2-part re-examination, minimum forty (40) hours of further training received in all applicable subjects listed in Table Plant Inspectors Competency Requirements.
- b. Part A retest, minimum sixteen (16) hours of further training received in the subjects listed under Part A in Table Plant Inspectors Competency Requirements.

3.4 Specialist Plant Inspector
